ELIGIBILITY: All competitors must be individual members of USA Shooting. This competition is open to all competitors **born in 2001 or later**. You are eligible to shoot this match as long as you will not be 21 years old on or before May 1, 2021. Only U.S. Citizens competing for the USA will be eligible for medals at both the State JOSOC and the NJOSOC.

CATEGORIES: The following categories will be used for individual competition:

Open Junior (J1)	Sub Junior (J2)	Novice (J3)
<i>Born 2001, 2002, 2003</i>	<i>Born 2004, 2005, 2006</i>	<i>Born 2007 or later</i>

NJOSOC ELIGIBILITY: For the 2021 National Junior Olympic Shooting Championships, *there will be NO MINIMUM required score*. HOWEVER, you must have registered targets in your State JO, have shot the appropriate discipline at the Selection Match in Kerrville (April 2021), or are currently a member of the National Team (NT), National Junior Team (NJT), or JO Squad.

USAS Exception: Blue Jeans, Jeans, and Camouflage will be permitted (no holes)

COURSE OF FIRE: 125 targets **Trap or Skeet**

COACHING: Coaching will not be permitted during the match on the field of play.

Non Verbal coaching is allowed.

TIES: All ties will be broken in accordance with ISSF Rules.

FINALS: Finals are allowed for practice only and only if time permits. All match awards will be based on Match Score only (no finals).

REFUNDS: Refunds requested prior to April 26, 2021 will be processed minus a \$15 processing fee. After April 26, will be at the Match Director’s discretion.

RESIDENCE: Each competitor may claim residence in only one state and must declare the state of residence on the entry form. Residency is defined as to where the competitor holds a current and valid driver’s license. If the competitor does not have a driver’s license, residency is then defined as to where the competitor’s parents/guardians reside. Additional questions – please contact the match director.
